TERMS AND CONDITIONS

1. **All Buskers entered in the competition are required to attend a Busker Briefing session at 9.30am in the CBD Pavillion.**
2. By submitting this Registration Form to BundyBusk, you acknowledge that you have read, accepted and understood the Terms and Conditions set out as follows. Please sign the bottom of this page to acknowledge that you have read, understood and accepted all these terms and conditions. Any registration form returned without a signature on the bottom of this page will be rejected.
3. To be eligible to win any prize in this competition you must register with the Youth Development Officer with Bundaberg Regional Council, to be allocated your busking site. Sites are limited and will be allocated based on date registration is received and fully completed.
4. Judging will be conducted during the event on Saturday 1 October 2011, by a selected judging panel for the main prize money and also the public voting for their favorite busker/s for the "Peoples Choice Award".
5. The judge's decision will be final and no correspondence will be entered into in any regard.
6. The winner(s) of the BundyBusk busking competition will be announced at approximately 1.00pm on Saturday 1 October in the CBD Pavillion. Each act will be required to perform their act to the audience in the CBD Pavilion before announcement of the winners.
7. **Prize Money**
 - a. 1st prize each division will be \$225
 - b. 2nd prize each division will be \$150
 - c. 3rd prize each division will be \$90
 - d. Peoples choice award overall will be \$70
8. Any groups entering this competition will be limited to five (5) members.
9. Buskers will be responsible for starting (10am) and finishing (12pm) on time and staying within their designated area whilst performing. Any busker not at their designated venue or area at the commencement of the competition time may forfeit their place in the competition.
10. Buskers are responsible for leaving the busking site clean and clear at the conclusion of the competition (12 noon).
11. Competitors must provide own equipment. Council will not provide or take responsibility for any supply of power, fittings or associated objects.
12. Entrants must adhere to all directions from the Event Manager, Council Staff and event volunteers, failure to do so, may result in disqualification and removal from the competition.
13. Buskers must not use dangerous implements or materials as part of a performance. No flames, pyrotechnics or weapons to be used in a performance.
14. You undertake to ensure that the performance and associated fixtures shall be positioned to allow suitable access for pedestrians at all times.
15. You undertake to ensure that the activity shall be carried out so as not to endanger or do anything which is likely to endanger the public.
16. All entrants of the competition must be reasonably available for publicity photos and to talk with the press if required.
17. Any Breach of these terms and conditions shall render the party in breach and ineligible for any prize in the competition and may also result in the party being asked to cease performing.
18. Upon signing this forms , entrants authorize Bundaberg Regional Council to use photographs and footage of their performances for promotional and marketing purposes.
