#### **PUBLIC NOTICE BUNDABERG REGIONAL COUNCIL ADOPTION OF LOCAL GOVERNMENT INFRASTRUCTURE PLAN (LGIP) AMENDMENT TO THE BUNDABERG REGIONAL COUNCIL PLANNING SCHEME AND RELATED AMENDMENTS TO THE PLANNING SCHEME AND PLANNING SCHEME POLICY FOR DEVELOPMENT WORKS**

Notice is given under the *Sustainable Planning Act 2009* that on 24 April 2018 Bundaberg Regional Council adopted an amendment to the Bundaberg Regional Council Planning Scheme 2015 to include a Local Government Infrastructure Plan (LGIP) and associated amendments to the Planning Scheme and Planning Scheme Policy for Development Works.

The adopted amendments take effect on and from 7 May 2018.

The purpose and general effect of the LGIP is to:

- integrate infrastructure planning with land use planning identified in the planning scheme;
- identify trunk infrastructure necessary to support future urban development;
- ensure trunk infrastructure is planned and provided in an efficient, cost effective and orderly manner;
- ensure the planned trunk infrastructure is financially sustainable and aligns with Council's asset management and long term financial planning; and
- provide a basis for Council to levy infrastructure charges and condition the provision of trunk infrastructure as part of development.

The purpose and general effect of the associated amendments to Council's Planning Scheme and Planning Scheme Policy for Development Works is to –

- make the necessary amendments to integrate the LGIP into the Planning Scheme and Planning Scheme Policy for Development Works; and
- ensure the Planning Scheme Policy for Development Works reflects the desired standard of service for development infrastructure identified in the LGIP.
